Scope of Work and Deliverables:

Term and Termination:

This Agreement shall commence upon execution and continue until completion of services or termination by either party with prior written notice as specified herein. Either party may terminate this Agreement for cause upon material breach not cured within a reasonable period following notice.

Compensation and Payment Terms:

Client shall pay Contractor the agreed compensation as outlined below, according to the specified schedule. Payments shall be made promptly upon receipt of valid invoices. Late payments may incur interest as permitted by law.

Performance Standards:

Contractor warrants that services will be performed in a professional and workmanlike manner, conforming to generally accepted industry standards and the specifications agreed upon by the parties.

Confidentiality:

Each party agrees to maintain the confidentiality of all proprietary or confidential information received from the other party during the term of this Agreement and to use such information solely for the purposes of performing this Agreement.

Intellectual Property Rights:

All intellectual property developed or delivered by Contractor in connection with the performance of this Agreement

shall be the sole property of the Client, except as otherwise agreed in writing.

Indemnification:

Each party agrees to indemnify, defend, and hold harmless the other party from and against any claims, damages, liabilities, costs, and expenses arising out of any breach of this Agreement or negligence.

Limitation of Liability:

Neither party shall be liable for any indirect, incidental, consequential, special, or punitive damages arising out of or related to this Agreement, even if advised of the possibility of such damages.

Force Majeure:

Neither party shall be responsible for any failure or delay in performance due to causes beyond its reasonable control, including but not limited to acts of God, government actions, natural disasters, or labor disputes.

Governing Law and Dispute Resolution:

This Agreement shall be governed by and construed in accordance with the laws of the State of _____. Any disputes arising hereunder shall be subject to the exclusive jurisdiction of the state or federal courts located in _____ County, _____.

Entire Agreement; Amendments:
